Russia Bans LinkedIn for Violating Data Protection Laws

UPDATE (11/17): Russian Internet service providers (ISPs) have been ordered to block public access to LinkedIn following a court ruling that found the social network guilty of violating data laws.

Russian law, [as reported by Reuters](#), requires websites that store citizens' personal data to do so on local servers. But the US-based business network—which boasts more than 6 million registered users in Russia—does not do so, watchdog Roskomnadzor said.

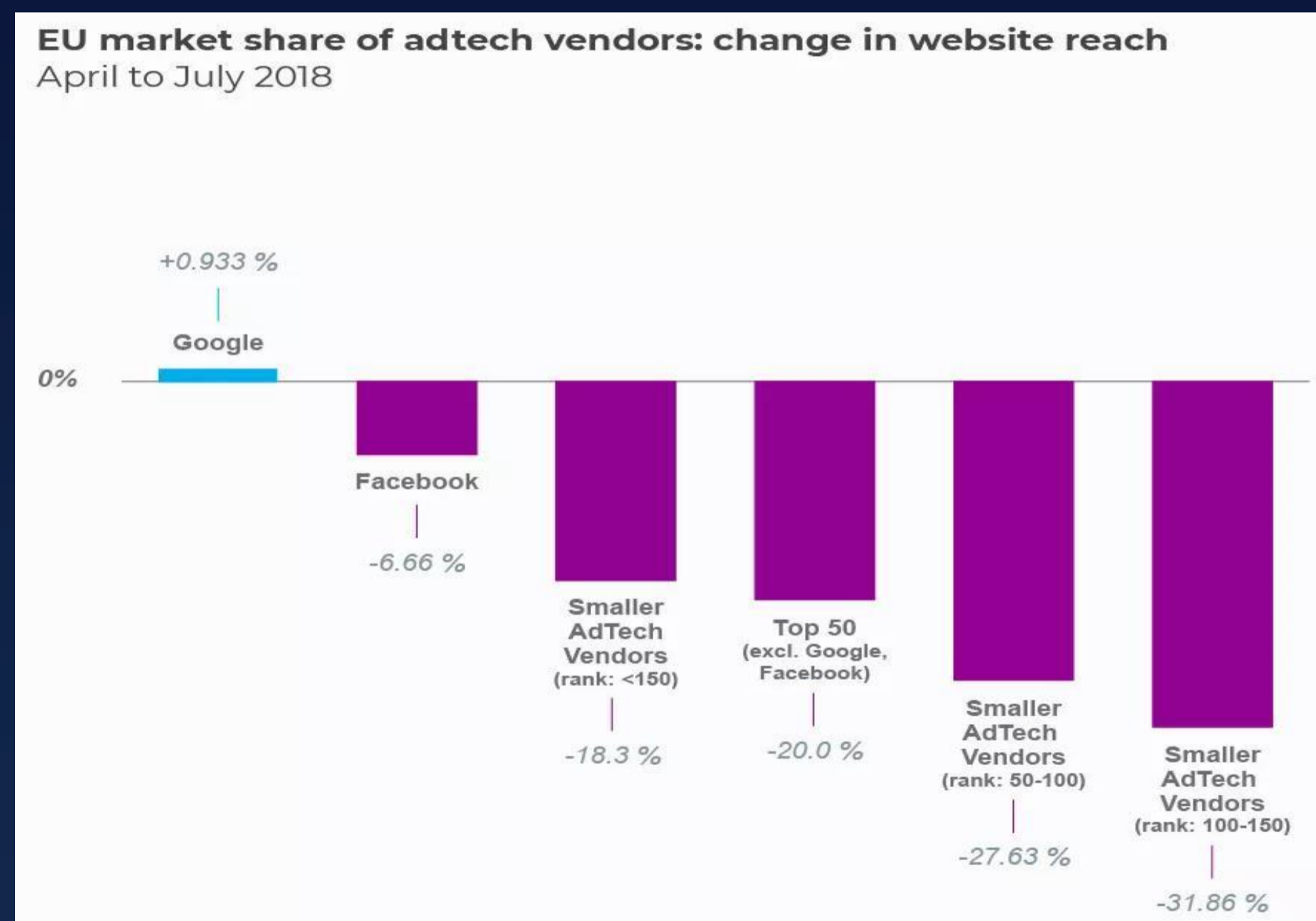

GDPR生效

一般数据保护法规于2018年5月25日实施，给企业2年时间准备实施。
欧盟各国统一法律，统一执法标准。

强大的域外适用效力

该条例适用于在欧盟境内不存在设立机构的数据控制者或处理者对欧盟境内数据主体的个人数据所实施的处理行为，如果该处理行为涉及：(a) 对欧盟境内的数据主体提供商品或服务，无论数据主体是否被要求付费；或者 (b) 监控欧盟境内数据主体的行为，只要他们的行为发生在欧盟境内。

高额的赔偿款

最高罚金分别为1000万欧元或上财年全球营业总额的2%中高者；或2000万欧元或上财年全球营业总额的4%中高者

GDPR: *noyb.eu* filed four complaints over "forced consent" against Google, Instagram, WhatsApp and Facebook

Privacy à la "take it or leave it"? The new General Data Protection Regulation (GDPR) which came into force today at midnight is supposed to give users a free choice, whether they agree to data usage or not. The opposite feeling spread on the screens of many users: tons of "consent boxes" popped up online or in applications, often combined with a threat that the service can no longer be used if users do not consent. On the first day of GDPR *noyb.eu* has therefore filed four complaints against Google (Android), Facebook, WhatsApp and Instagram over "forced consent".

Overview of the complaints. Very similar complaints were filed with four authorities, to enable European coordination. In addition to the four authorities at the residence of the users, the Irish Data Protection Commissioner ([link](#)) will probably get involved in the cases too, as the headquarter of the relevant companies is in Ireland in three cases.

GERMANY: FIRST COURT DECISION ON GDPR

Only five days after the GDPR became applicable, the first German court, the Regional Court (*Landgericht*) Bonn (in a decision dated 29 May 2018, case number 10 O 171/18 – in German only), issued a ruling on the practical application of the GDPR. This probably makes the court's ruling the first GDPR court decision worldwide, and the decision addressed the hot-button issue of public availability of ICANN "WHOIS data".

The Information Commissioner's Office ("ICO") in the UK has issued the first formal enforcement action under the EU General Data Protection Regulation (GDPR) and the UK Data Protection Act 2018 (the "DPA") on Canadian data analytics firm AggregatIQ Data Services Ltd. ("AIQ"). The enforcement action, in the form of an Enforcement Notice served under section 149 of the DPA, requires AIQ to "cease processing any personal data of UK or EU citizens obtained from UK political organizations or otherwise for the purposes of data analytics, political campaigning or any other advertising purposes."

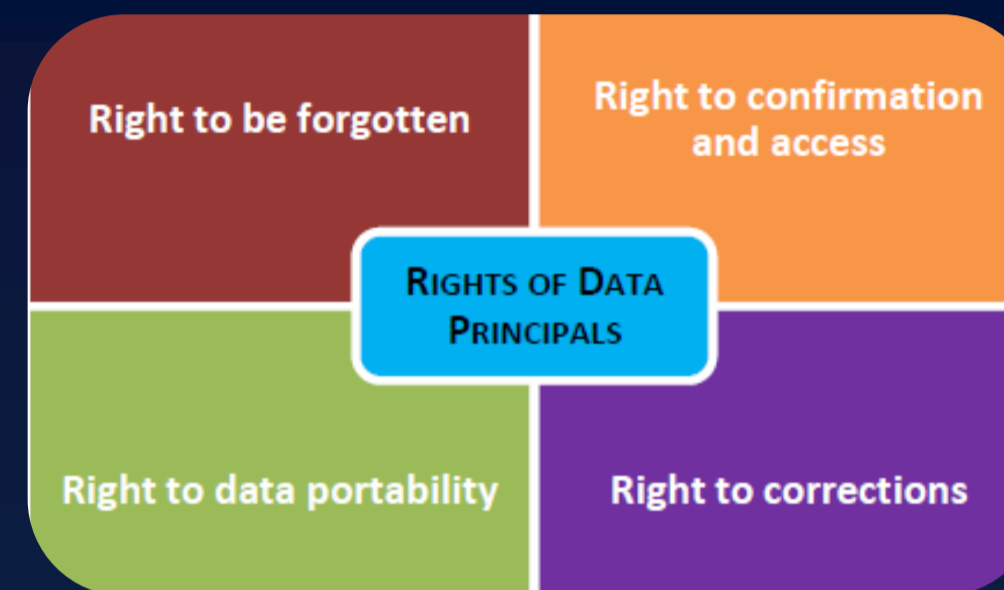
